I declare that the shipowner of the M/S Skorpios III, Naviera y Turismo Skorpios S.A., a Chilean company, TIN 96,510,510-7, henceforth the "transporter", has fully and adequately informed me of any and all conditions and risks involved in the contracted trip and its accompanying activities published in the brochures and on its website www.skorpios.cl.

I further declare that I am fully and completely aware that the trip and its associated activities organized by the carrier will take place in rough places far from urban centers; that they do not have hospital and/or care facilities that can provide medical services - beyond first aid - in a timely manner that can be reached quickly in the event of an accident, illness and/or any other type of physical or psychological condition that affects the physical or mental health of the undersigned.

I hereby state for the record that the carrier has informed me about the conditions of the hiking trips and their risks, before and during the cruise, through its guides, regarding the physical capabilities required to carry out the various activities; as well as the fact that, should it be required, it will not be possible to obtain the provision of medical care beyond first aid.

Furthermore, I state that I have fully and sufficiently informed the carrier that I do not suffer from any physical or mental illness, or from any incapacity or condition that could increase the risks of the trip or the planned activities by preventing me from performing the former and/or the latter, and that I am in adequate health to embark.

Finally, I declare I am fully aware that during the contracted transport I may suffer ailments or accidents related to it, and other ailments or accidents unrelated to it, such as and without this being an exhaustive list, heart attacks, vascular and/or brain accidents, respiratory insufficiencies, etc.

Without prejudice to the unwaivable rights that I have under the legal regime applicable to the ticket (passage contract) and in the period that is proper to it, in the event of participating in any activity organized by the carrier I expressly declare that the carrier and/or its dependents and/or associates have no responsibility for accidents and/or illnesses that may occur to me or affect me during such activities and that do not fall within the scope of passenger transport or its period of execution.



Consequently, the undersigned declares expressly and unreservedly that they decide voluntarily and in full use of their capabilities, to participate, to remain, and/or to develop the activities organized by the carrier that do not correspond to the period and scope of the transport itself, under their entire and exclusive responsibility.

The carrier and/or its employees and/or associates shall not be liable for any permanent or temporary injuries or sequelae that the undersigned may suffer because of illness and/or accidents arising from the aforementioned activities, nor for any damages that such injuries or sequelae may cause with this regard.

I expressly state that even in the event of accidental death or death caused by the injuries or diseases suffered during these activities, the carrier and/or its employees and/or associates shall not incur in any liability.

Finally, I declare I am accompanied by the following minors (name, identity document and address) and that they are under my care:

Such minors shall carry out the activities and excursions organized by the carrier under my sole and full responsibility. For this purpose, I declare to be willing to sign all the documentation required for it and indicated to me by the carrier and/or its employees. Accordingly, I hereby release the carrier and/or its dependents and/or associates from all liability for any illness, accident, injury, damage and/or harm, including death, that the identified minors may suffer during or because of the above activities.

My agents, administrators, successors, heirs and/or legatees shall be bound by the above statement.

Finally, I declare to be aware that during the voyage Skorpios Cruises will obtain photographic and audiovisual records of their facilities and/or passengers, on board their ships and/or in expeditions outside of them, in which I and/or the minors traveling under my supervision may appear. Such records may be used for purely promotional or advertising purposes on the Skorpios Cruises website and/or on its social media pages. In the event of not authorizing the above, the passenger must declare it in writing.

I also declare that I know and accept the Fare Conditions and the Passage Contract in force for the season corresponding to my voyage, both published on the website www.skorpios.cl and to be aware of the safety instructions and directions the captain and his officers will give me during my cruise.
